Tour to see the waterfront, Downtown,
Gaslamp Quarter, Pt. Loma with Cabrillo
Monument, historic Spanish Old Town,
Heritage Park Victorian Village (filled with
1890's homes), and Coronado Island. This
afternoon visit the impressive USS Midway
Museum, the retired aircraft carrier was in

service from 1945-1992 and saw action in both the Korean and Vietnam Wars. Later enjoy a San Diego Harbor Cruise featuring a narrated tour that takes you under the Coronado Bridge, past military ships, waterfront landmarks and marine life for an up-close, in-depth look at San Diego's beauty and fascinating history. Dinner tonight is included at a local restaurant.

## DAY 3: PALM SPRINGS - TEMECULA VALLEY WINERY

Today travel to the desert to visit Palm Springs. Enjoy leisure time for a bit of shopping and lunch on your own in downtown Palm Springs. Later, relax

and enjoy the scenery as you travel to the picturesque Temecula Valley to visit a local winery for a **Wine Tasting Experience**. The Temecula Valley features over 40 wineries offering award-winning wines due to its micro-climate of morning mist, midday warmth and cool ocean breezes. Return to your hotel for an evening at your own pace.

Then stop in picturesque La Jolla for leisure time to wander, shop or maybe visit the famous La Jolla Cove. Tonight your Farewell Dinner is at a local restaurant in San Diego.
